- Anti-dumping and Anti-subsidy cases with findings of no injury, such as paint brushes, grey cotton fabrics, school bags, luggage suitcases, textile handbags, energy saving lamp, PSF, castings, glyphosate; soya protein, WWAN modems and low carbon ferro-chrome, etc.
- Anti-circumvention cases with duty exemption, such as zinc oxide, fasteners.
- Successful negotiation for product exclusion, such as glass fibers and tool steels.
- Successful negotiation for price undertakings, such as citric acid, magnesia bricks and solar panels, etc.
- Successful negotiation for floor price, such as dihydrostreptomycin, frozen strawberries.
